Client agrees to indemnify and hold Bartender harmless from any liability, claims, damages, or expenses (including attorney fees) arising out of Client's negligence or misconduct during the event. Bartender shall maintain all required licenses and insurance for the provision of bartending services. Bartender is not responsible for the conduct of event guests or for any injuries or damages resulting from alcohol consumption by guests.

## Cancellation Policy:

Either party may cancel this Agreement by providing written notice to the other party. Deposit payments, if any, are non-refundable unless cancellation is made more than 7 days prior to the event. If Client cancels within 7 days of the event, Client remains responsible for the full fee. Bartender reserves the right to cancel due to unforeseen circumstances.

**Compliance with Laws and Regulations:**

Bartender shall comply with all federal, state, and local laws, ordinances, and regulations applicable to the services provided under this Agreement, including those governing alcohol service. Client shall ensure that the event premises meet all requirements for lawful alcohol service.

**Independent Contractor Status:**

Bartender is an independent contractor and not an employee, agent, or partner of Client. Bartender is solely responsible for payment of all taxes and insurance relating to the services rendered.

**Force Majeure:**

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, fire, flood, natural disasters, government actions, or public health emergencies.

**Entire Agreement:**

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements. Any amendments must be in writing and signed by both parties.

**Governing Law and Venue:**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_ without regard to conflict of law principles.
