Terms and Conditions:

1. Rental and Use

The Rental Company agrees to rent the Vehicle to the Renter, and the Renter agrees to rent the Vehicle subject to the terms of this Agreement. The Vehicle shall be used only for lawful purposes and driven only by the Renter or authorized drivers listed herein. The Vehicle shall not be used for hire, towing, racing, or off-road driving.

2. Driver's License and Age Requirements

The Renter represents that they hold a valid driver's license issued by a recognized authority and meet the minimum age requirements to rent and operate the Vehicle. The Renter shall provide a copy of the driver's license prior to taking possession of the Vehicle.

3. Vehicle Condition and Inspection

The Renter acknowledges receipt of the Vehicle in good condition and agrees to return the Vehicle in the same condition, normal wear and tear excepted. Any existing damage is noted in the attached Vehicle Condition Report which forms part of this Agreement.

4. Insurance and Liability

The Vehicle is insured by the Rental Company as required by law. The Renter shall be responsible for the cost of any

damage to the Vehicle or third-party property caused by the Renter's negligence, up to the amount of the Security Deposit. The Renter shall indemnify and hold harmless the Rental Company from any claims, damages, or losses arising from the use of the Vehicle during the rental period.

5. Maintenance and Repairs

The Renter shall not perform or authorize repairs without prior consent from the Rental Company, except in cases of emergency to prevent further damage or risk. The Rental Company is responsible for routine maintenance during the rental period.

6. Fuel

The Vehicle will be provided with a full tank of fuel and must be returned with a full tank. If the Vehicle is returned with less fuel, the Renter agrees to pay for refueling at prevailing rates plus any applicable service fees.

7. Prohibited Uses

The Vehicle shall not be used for any illegal purpose, or by any person under the influence of alcohol, drugs, or any other substances that impair driving ability. The Renter shall not allow any unauthorized driver to operate the Vehicle.

8. Termination

The Rental Company reserves the right to terminate this Agreement and repossess the Vehicle at any time if the Renter breaches any terms herein or uses the Vehicle in an unsafe or unlawful manner.

9. Return of Vehicle

The Renter agrees to return the Vehicle to the Rental Company at the agreed location and time. Late returns may be subject to additional charges as specified by the Rental Company.

10. Privacy and Personal Information

The parties will process personal information solely for purposes related to this Agreement, including verification, billing, and compliance with legal obligations. Reasonable safeguards will be applied.

11. Governing Law and Jurisdiction

This Agreement is governed by the laws of the State of _____, United States. Any disputes arising under this Agreement shall be resolved exclusively in the courts located in _____ County, _____.

12. Entire Agreement

This Agreement constitutes the entire agreement between the parties concerning the rental of the Vehicle and supersedes all prior discussions or agreements. Amendments must be in writing and signed by both parties.

13. Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.
