Chore Description and Scope of Work:

The Contractor agrees to perform the following chores and services as requested by the Client, including but not limited to cleaning, maintenance, errands, and any other agreed tasks. The scope, timing, and manner of performance shall be as mutually agreed upon in writing or verbally prior to the commencement of each chore.

Term and Termination:

This Contract is effective upon execution and shall continue until terminated by either party with advance written notice. Either party may terminate this Contract at any time for any reason with at least 24 hours' notice, except where otherwise agreed. Termination shall not relieve the Client of payment obligations for chores completed prior to termination.

Payment Terms:

The Client shall compensate the Contractor at the agreed hourly rate or fixed fee per chore as specified in writing prior to service. Payment shall be made promptly upon completion of the chore or as otherwise agreed. Late payments may incur interest as allowed by applicable law.

Independent Contractor Status:

The Contractor is engaged as an independent contractor and not as an employee of the Client. Nothing in this Contract shall be construed to create an employer-employee relationship, partnership, joint venture, or agency relationship between the parties.

Liability and Insurance:

The Contractor shall perform all chores with due care and in a professional manner. The Contractor is responsible for maintaining any necessary insurance coverage to cover liability arising from the performance of the chores. The Client

shall not be liable for any injury, loss, or damage sustained by the Contractor during performance of the Contract.

Confidentiality:

The parties agree to keep confidential all private, proprietary, or sensitive information obtained during the term of this Contract and not to disclose such information to any third party except as required by law or with prior written consent.

Governing Law and Dispute Resolution:

This Contract shall be governed by and construed in accordance with the laws of the United States and the state in which the Client resides. Any disputes arising under or in connection with this Contract shall be resolved through negotiation in good faith or, if necessary, binding arbitration in accordance with the rules of the American Arbitration Association.

Indemnification:

The Contractor agrees to indemnify and hold harmless the Client from and against any and all claims, damages, liabilities, costs, and expenses arising from the Contractor's negligence, willful misconduct, or breach of this Contract.

Entire Agreement:

This Contract constitutes the entire agreement between the parties and supersedes all prior agreements and understandings, whether written or oral, relating to its subject matter. Any amendments or modifications must be in writing and signed by both parties.

Severability:

If any provision of this Contract is found to be invalid or unenforceable, the remainder of the Contract shall remain in full force and effect and such provision shall be replaced by a valid provision that most closely reflects the parties' intent.

Notices:

All notices, requests, demands, and other communications under this Contract shall be in writing and properly addressed to the parties at their respective addresses provided above, and shall be deemed given when delivered personally, sent by certified mail, or by nationally recognized overnight courier service.

Waiver:

The failure of either party to enforce any provision of this Contract shall not be construed as a waiver of that provision or any other provision of this Contract.
