Contract Clauses:

1. Agreement to Deliver

The Deliverer agrees to deliver the item(s) described above (the "Goods") to the Recipient in accordance with the terms and conditions of this Contract.

2. Delivery Condition and Acceptance

The Goods shall be delivered in the condition described above. Recipient shall inspect the Goods upon delivery and shall notify Deliverer of any defects or issues immediately. Failure to notify within a reasonable time shall constitute acceptance.

3. Risk of Loss

Risk of loss or damage to the Goods shall transfer from Deliverer to Recipient upon physical delivery at the agreed location.

4. Payment

Recipient agrees to pay the Total Amount Due as specified above by the agreed Payment Method. Payment shall be

made in full upon delivery unless otherwise agreed in writing.

5. Title

Title and ownership of the Goods shall transfer upon full payment and delivery.

6. Warranties

Deliverer warrants that it has the right to deliver the Goods and that the Goods are free of liens and encumbrances. Except as expressly stated, Goods are delivered AS IS, without warranties of merchantability or fitness.

7. Indemnification

Each party agrees to indemnify and hold harmless the other from any claims, losses, damages, or liabilities arising out of breach of this Contract or negligent acts.

8. Governing Law

This Contract shall be governed by and construed in accordance with the laws of the United States and the State in which the delivery location is situated, without regard to conflict of law principles.

9. Dispute Resolution

Any disputes arising under this Contract shall be resolved by binding arbitration in the jurisdiction of the delivery location, and the parties waive their rights to a jury trial.

10. Entire Agreement

This Contract constitutes the entire agreement between the parties concerning the delivery and supersedes all prior agreements and understandings.

11. Amendments

Any modifications to this Contract must be made in writing and signed by both parties.

12. Notices

All notices must be in writing and delivered personally, by certified mail, or electronic communication with confirmation.

13. Severability

If any provision is held invalid or unenforceable, the remainder of the Contract shall remain in full force and effect.

14. Counterparts

This Contract may be executed in counterparts, each of which shall be deemed an original.
