DJ RESPONSIBILITIES:

DJ agrees to provide professional DJ services at the event specified above, including music selection, mixing, and equipment setup as agreed. DJ will arrive timely to set up and perform the contracted services during the agreed performance period. DJ shall provide all necessary equipment unless otherwise specified in writing. DJ maintains the right to refuse any requests inconsistent with professional standards or local laws.

CLIENT RESPONSIBILITIES:

Client shall provide access to the event location, electricity, and adequate space for DJ setup. Client agrees to comply with all venue rules and regulations and ensure a safe working environment for the DJ. Client shall not hold the DJ liable for circumstances beyond the control of the DJ, including but not limited to power failures, equipment malfunction, or disturbances caused by event attendees.

CANCELLATION POLICY:

Either party may cancel this Agreement by providing written notice to the other party. If Client cancels within 14 days of the event, the deposit shall be forfeited. If DJ cancels, all fees paid by Client shall be refunded promptly. No other damages or penalties shall apply unless otherwise agreed in writing.

INDEMNIFICATION AND LIABILITY:

Each party agrees to indemnify and hold harmless the other party from any claims, damages, losses, or expenses arising from negligence or willful misconduct related to this Agreement. DJ's liability for any claim arising out of this Agreement shall not exceed the total fees paid by Client.

GOVERNING LAW AND DISPUTE RESOLUTION:

This Agreement shall be governed by and construed in accordance with the laws of the United States and the state where the event occurs. Any disputes shall be resolved through binding arbitration in the jurisdiction of the event location, and the parties waive the right to a trial by jury.

ENTIRE AGREEMENT:

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements, whether written or oral, relating to the subject matter herein. Any modifications must be in writing and signed by both parties.
