Section 1 – Engagement

Producer hereby engages Director to render directing services for the production of the film described above (the “Film”), subject to the terms and conditions set forth herein.

Section 2 – Services

Director agrees to perform all directing services reasonably required to complete the production of the Film in a professional, timely, and workmanlike manner.

Section 3 – Term

The term of this Agreement shall commence upon signing and continue until completion and delivery of the Film, unless earlier terminated in accordance with this Agreement.

Section 4 – Compensation

Producer shall pay Director the total fee specified above in accordance with the payment schedule. All payments shall be made by wire transfer or other immediately available funds.

Section 5 – Credits

Director shall receive screen credit as 'Director' in the main titles or end credits of the Film, subject to industry standards and mutual agreement.

Section 6 – Work for Hire; Ownership

Director acknowledges that all services performed hereunder constitute 'work made for hire' and any and all rights, title

and interest in the Film and all related materials shall be the sole property of the Producer.

Section 7 – Representations and Warranties

Director represents and warrants that Director has the right to enter into this Agreement, that the services will be original and not infringe any third party rights, and that Director will comply with all applicable laws.

Section 8 – Confidentiality

Director agrees to keep confidential any proprietary or non-public information disclosed during the course of this Agreement and not to disclose such information without Producer's prior written consent.

Section 9 – Indemnification

Each party shall indemnify and hold harmless the other from and against any claims, losses, damages, liabilities, costs, and expenses arising out of breach of this Agreement or negligence.

Section 10 – Termination

This Agreement may be terminated by either party upon material breach by the other party if such breach remains uncured for a period of thirty (30) days following written notice.

Section 11 – Force Majeure

Neither party shall be liable for delays or failure to perform due to causes beyond their reasonable control, including natural disasters, strikes, or governmental actions.

Section 12 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes shall be subject to the exclusive jurisdiction of the courts located in _____ County, _____.

Section 13 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, and agreements.

Section 14 – Amendments

Any amendment or modification of this Agreement must be in writing and signed by both parties.

Section 15 – Notices

All notices under this Agreement shall be in writing and deemed delivered when sent by certified mail, nationally recognized overnight courier, or email with confirmation.

Section 16 – Independent Contractor

Director is an independent contractor and is not an employee, agent, or partner of Producer.

Section 17 – Compliance with Laws

Director agrees to comply with all applicable federal, state, and local laws, statutes, ordinances, regulations, and codes.

Section 18 – Non-Assignment

Neither party may assign this Agreement or any rights or obligations hereunder without the prior written consent of the other party.

Section 19 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Section 20 – Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute one Agreement.
