RECITALS:

WHEREAS, Releasor desires to fully and finally release Releasee from any and all claims, demands, actions, causes of action, debts, liabilities, agreements, promises, damages, and expenses, whether known or unknown, suspected or unsuspected, that Releasor may have against Releasee arising out of or related to any matter occurring prior to the date of this General Release Form.

AGREEMENT:

1. Release.

Releasor hereby fully and forever releases and discharges Releasee, including its agents, employees, representatives, successors, and assigns, from any and all claims, demands, liabilities, causes of action, damages, and expenses of any kind, whether known or unknown, fixed or contingent, which Releasor has or may have against Releasee arising out of or related to the matters described in the Recitals or any other matter prior to the execution of this Agreement.

2. No Admission of Liability.

This General Release Form does not constitute an admission of liability or wrongdoing by any party and shall not be construed as such.

3. Consideration.

Releasor acknowledges that the promises and obligations contained herein constitute sufficient and adequate consideration for this Release.

4. No Pending Claims.

Releasor represents and warrants that Releasor has not filed or initiated any lawsuits, claims, or demands against Releasee arising out of or related to the matters released herein.

5. Governing Law.

This General Release Form shall be governed by and construed in accordance with the laws of the State of _____ without regard to its conflict-of-law principles.

6. Severability.

If any provision of this General Release Form is held to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

7. Entire Agreement.

This General Release Form contains the entire agreement between the parties and supersedes any prior oral or written understandings, agreements, or representations.

8. Binding Effect.

This General Release Form shall be binding upon and inure to the benefit of the parties and their respective heirs, executors, administrators, successors, and assigns.

9. No Waiver.

No failure or delay by any party in exercising any right under this General Release Form shall operate as a waiver of such right, nor shall any single or partial exercise preclude any other or further exercise.

10. Representation by Counsel.

Each party acknowledges that it has had the opportunity to consult with legal counsel prior to execution of this General Release Form.

11. Execution in Counterparts.

This General Release Form may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

Headings used in this General Release Form are for convenience only and shall not affect the interpretation of any provision herein.

13. No Oral Modification.

Any modifications to this General Release Form must be in writing and signed by both parties.

14. Authority.

Each person signing this General Release Form represents and warrants that they have the full legal authority to execute this General Release Form on behalf of the party for whom they sign.

15. Survival.

The representations, warranties, and agreements contained in this General Release Form shall survive the execution and delivery of this General Release Form.

16. No Assignment.

Releasor may not assign any of its rights or obligations under this General Release Form without the prior written consent of Releasee.

17. Further Assurances.

Each party agrees to execute and deliver such further documents and take such further actions as may be reasonably necessary to effectuate the intent and purposes of this General Release Form.

18. Interpretation.

This General Release Form shall be interpreted fairly in accordance with its terms and without any strict construction in favor of or against any party.

19. Notices.

All notices required or permitted under this General Release Form shall be in writing and shall be deemed given when delivered by hand, overnight courier, certified mail return receipt requested, or by electronic means with confirmation of receipt, to the addresses set forth herein.

20. Effective Date.

This General Release Form shall become effective as of the date of the last party's signature below.
