1. Engagement of Services

Stylist agrees to provide professional hair styling services to Client as detailed in this Agreement. Stylist shall perform all services with reasonable care, skill, and diligence consistent with industry standards.

2. Term

This Agreement shall commence on the Effective Date and shall continue until the completion of the services described herein, unless terminated earlier in accordance with this Agreement.

3. Payment

Client agrees to pay Stylist the Service Fee as specified above. Payment shall be made in full upon completion of the services unless otherwise agreed in writing. Late payments may incur additional fees.

4. Cancellation and Rescheduling

Client may cancel or reschedule an appointment with no less than 24 hours notice. Failure to provide timely notice may result in a cancellation fee equal to 50% of the Service Fee.

5. Client Representations

Client represents that they have no known allergies or medical conditions that would affect the services provided. Client agrees to inform Stylist of any such conditions prior to services.

6. Liability

Stylist shall not be liable for any damages or injuries resulting from Client's failure to disclose relevant medical information or allergies. Client assumes all risks associated with the services.

7. Confidentiality

Stylist agrees to keep confidential all personal information disclosed by Client during the course of services, except as required by law or as necessary to perform the services.

8. Compliance with Laws

Both parties agree to comply with all applicable federal, state, and local laws, rules, and regulations in connection with the performance of this Agreement.

9. Termination

Either party may terminate this Agreement at any time with written notice. Termination shall not relieve Client of obligations to pay for services rendered prior to termination.

10. Independent Contractor

Stylist is an independent contractor and not an employee of Client. Stylist shall be responsible for all taxes and insurance related to the services.

11. Indemnification

Client agrees to indemnify and hold harmless Stylist from any claims, damages, or liabilities arising out of Client's misuse or negligence during or after the services.

12. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflict of law principles.

13. Dispute Resolution

The parties agree to attempt to resolve any dispute arising under this Agreement through good faith negotiation. If unresolved, disputes shall be resolved through binding arbitration in accordance with the rules of the American Arbitration Association.

14. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior understandings. No modification shall be valid unless in writing and signed by both parties.

15. Severability

If any provision of this Agreement is found to be unenforceable, the remainder of the Agreement shall remain in full force and effect.

16. Waiver

Failure by either party to enforce any provision of this Agreement shall not be deemed a waiver of future enforcement of that or any other provision.

17. Notices

All notices under this Agreement shall be in writing and delivered by hand, certified mail, or electronic means with confirmation to the addresses stated herein.

18. Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, natural disasters, or government actions.

19. Non-Discrimination

Stylist agrees to provide services without discrimination on the basis of race, color, religion, sex, national origin, age, disability, or any other protected status.

20. Signature and Acceptance

By signing below, the parties acknowledge that they have read, understood, and agree to be bound by the terms of this Agreement.
