

LEGAL TEMPLATE LOGIN AGREEMENT

PARTIES:

This Legal Template Login Agreement (the “Agreement”) is made by and between:

User (hereinafter referred to as “User”)

and

Service Provider (hereinafter referred to as “Provider”)

RECITALS

WHEREAS, User desires to access and use certain services provided by Provider via an online platform (the “Platform”); and WHEREAS, Provider agrees to grant User access under the terms and conditions set forth in this Agreement.

1. DEFINITIONS

“Account” means the registration and login credentials provided to User to access the Platform. “Confidential Information” means any non-public information disclosed by either party related to the Platform or business. “Services” means the functionality and offerings provided by Provider via the Platform.

2. ACCOUNT CREATION AND SECURITY

User agrees to provide accurate and complete information during registration and to maintain the confidentiality of login credentials. User is responsible for all activities occurring under their Account and must notify Provider immediately of any unauthorized use.

3. USER CONDUCT

User agrees not to use the Platform for any illegal or unauthorized purpose, including but not limited to infringement of intellectual property rights, transmission of harmful or offensive material, or any activity that may harm the Provider or other users.

4. PRIVACY AND DATA PROTECTION

Provider shall collect, use, and protect User’s personal information in accordance with applicable United States privacy laws and Provider’s Privacy Policy. User consents to such collection and use by registering and using the Platform.

5. INTELLECTUAL PROPERTY

All intellectual property rights in the Platform and Services, including software, content, trademarks, and logos, are owned by or licensed to Provider. User is granted a limited, non-exclusive, non-transferable license solely to access and use the Services as permitted herein.

6. TERM AND TERMINATION

This Agreement is effective upon User's acceptance and continues until terminated by either party. Provider may suspend or terminate User's access immediately for violation of this Agreement or applicable laws.

7. DISCLAIMERS AND LIMITATION OF LIABILITY

THE PLATFORM AND SERVICES ARE PROVIDED "AS IS" AND "AS AVAILABLE" WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED. PROVIDER DISCLAIMS ALL WARRANTIES INCLUDING MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. IN NO EVENT SHALL PROVIDER BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES ARISING OUT OF OR RELATING TO THIS AGREEMENT.

8. INDEMNIFICATION

User agrees to indemnify, defend, and hold harmless Provider and its affiliates from any claims, damages, losses, liabilities, costs, and expenses arising from User's breach of this Agreement or misuse of the Platform.

9. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of the United States and the applicable state law without regard to conflict of law principles. Any disputes arising under this Agreement shall be subject to the exclusive jurisdiction of the state and federal courts located in the appropriate venue.

10. MODIFICATIONS

Provider reserves the right to modify or update this Agreement at any time. User's continued use of the Platform after such changes constitutes acceptance of the modified terms.

11. SEVERABILITY

If any provision of this Agreement is determined to be invalid or unenforceable by a court, the remaining provisions shall remain in full force and effect.

12. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between User and Provider regarding the subject matter hereof and supersedes all prior or contemporaneous agreements, understandings, and communications.
