**Services and Equipment Provided:**

Lessor shall provide a fully operational photo booth unit including digital camera, lighting, touch screen monitor, and unlimited photo prints during the rental period. Lessor is responsible for setup, operation, and removal of the photo booth at the event location. Props, backdrops, and custom branding are included as specified in the attached Schedule.

**Renter Responsibilities:**

Renter shall provide safe and reasonable access to the event location for setup and removal of equipment. Renter is responsible for supervision of guests using the photo booth and agrees to prevent misuse or damage. Renter agrees not to move or tamper with the equipment once set up without prior consent from Lessor.

**Liability and Indemnification:**

Lessor is not liable for any injury, loss, or damage to persons or property arising from use of the photo booth, except to the extent caused by Lessor's gross negligence or willful misconduct. Renter agrees to indemnify and hold harmless Lessor from all claims, damages, and expenses arising from Renter's use or misuse of the equipment.

**Damage and Loss:**

Renter is responsible for loss or damage to the photo booth equipment during the rental period, except for reasonable wear and tear. Any damage or loss will be charged to Renter at replacement or repair cost. Security deposit may be applied to cover such charges.

**Cancellation Policy:**

Renter may cancel this Agreement by providing written notice to Lessor. If cancellation occurs prior to the agreed event date, any payments made may be refunded or forfeited according to the terms specified in the attached Schedule.

**Force Majeure:**

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, government restrictions, strikes, or other unforeseen events.

**Governing Law and Dispute Resolution:**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_, without regard to its conflict of law principles.
