## Clause 1 – Scope of Services

Photographer agrees to provide professional photography services as described herein, including shooting, editing, and delivery of photographs as specified in this Agreement. Services shall be performed at the agreed date(s) and location(s).

## Clause 2 – Client Obligations

Client agrees to provide access, necessary permissions, and cooperation to Photographer to enable completion of the services. Client is responsible for securing any required permits and authorizations for the event or location.

## Clause 3 – Payment Terms

Client shall pay the agreed fees as stated above. Deposit payments, if any, are due upon execution of this Agreement and are non-refundable except as otherwise provided herein. Final balance shall be due prior to or at the time of delivery of final images.

## Clause 4 – Cancellation and Rescheduling

Client may cancel or reschedule services by providing written notice to Photographer at least 14 days in advance. Deposits retained may apply as cancellation fees. Rescheduling is subject to Photographer's availability.

## Clause 5 – Delivery of Images

Photographer shall deliver edited digital images in the agreed format(s) within a reasonable period following the event or service date, typically not exceeding 30 days unless otherwise agreed.

**Clause 6 – Usage Rights and Licensing**

Photographer grants Client a non-exclusive, non-transferable license to use the delivered images for personal or commercial purposes as specified in this Agreement. Photographer retains all copyrights and may use images for promotional purposes unless Client requests otherwise in writing.

**Clause 7 – Model Releases and Privacy**

Client is responsible for obtaining any necessary model releases or permissions for identifiable individuals appearing in the photographs. Photographer is not liable for unauthorized use of images by third parties.

**Clause 8 – Liability and Indemnification**

Photographer shall perform services with reasonable care and skill but shall not be liable for any indirect, incidental, or consequential damages. Client agrees to indemnify and hold Photographer harmless from any claims arising out of Client's use or misuse of the images or services.

**Clause 9 – Force Majeure**

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including but not limited to acts of God, natural disasters, or governmental restrictions.

**Clause 10 – Governing Law and Venue**

This Agreement shall be governed by the laws of the State of \_\_\_\_\_ without regard to conflict-of-law rules. The parties consent to the exclusive jurisdiction and venue of the state or federal courts located in \_\_\_\_\_ County, \_\_\_\_\_.

**Clause 11 – Entire Agreement**

This Agreement constitutes the entire understanding between the parties regarding the subject matter and supersedes all prior negotiations or agreements, whether oral or written. Amendments must be in writing and signed by both parties.

**Clause 12 – Severability**

If any provision is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**Clause 13 – Independent Contractor**

Photographer is an independent contractor and not an employee or agent of the Client. Nothing in this Agreement shall be construed to create a partnership or joint venture.

**Clause 14 – Confidentiality**

Both parties agree to keep confidential any proprietary or sensitive information disclosed during the term of this Agreement.

**Clause 15 – Signatures and Counterparts**

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute one instrument.
