1. Scope of Work

Contractor agrees to provide professional window cleaning services to Client as described in this Proposal. Services include cleaning of all exterior and accessible interior windows, frames, sills, and tracks.

2. Service Schedule

Either party may terminate this Proposal with written notice. Client shall pay for all services rendered and materials used up to the date of termination.

9. Confidentiality

Both parties agree to keep confidential any proprietary information obtained during the term of this Proposal and not to disclose such information without prior written consent.

10. Governing Law and Dispute Resolution

This Proposal shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising under or in connection with this Proposal shall be resolved through negotiation or, if necessary, binding arbitration.

11. Entire Agreement

This document constitutes the entire agreement between the parties and supersedes all prior agreements or understandings, whether written or oral, related to the subject matter herein.

12. Amendments

Any amendments or modifications to this Proposal must be in writing and signed by authorized representatives of both parties.

13. Force Majeure

Neither party shall be liable for delays or failure to perform due to force majeure events beyond their reasonable control, including but not limited to natural disasters, strikes, or governmental actions.

14. Insurance

Contractor shall maintain appropriate insurance coverage for liability and worker's compensation as required by law.

15. Indemnification

Client agrees to indemnify and hold Contractor harmless from any claims, damages, or expenses arising out of Client's negligence or failure to comply with obligations.

16. Safety and Compliance

Contractor will comply with all relevant federal, state, and local laws and regulations applicable to services performed under this Proposal.

17. Subcontracting

Contractor may engage subcontractors to perform services but remains responsible for the quality and timely completion of all work.

18. Notices

All notices under this Proposal shall be in writing and delivered to the addresses provided by each party.

19. Severability

If any provision of this Proposal is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

20. Signatures

This Proposal may be executed in counterparts and is effective upon signature by authorized representatives of both parties.
